GENERAL RULES

CHAPTER 1 – GENERAL DEFINITIONS

1.1. PLACE AND DATE OF THE FAIR

THE EGG, Rue Bara 175, 1070 Brussels.
The fair will take place on Sunday 12th January 2025.
On Saturday 11th January 2025 the exhibitors must install their stand between 09.00am and 20.00pm.
On Sunday 12th January 2025:
7.00am – 9.00am: Installation of the collections by the exhibitors
9.00am – 18.00pm: Opening of the fair
18.00pm – 23.00pm: Closure of the fair and clean-up the booth.

1.2. REGISTRATION PROCEDURE

The participation form is attached to the general rules. To be registrated, the attached form needs to be filled in. The form needs to be completed and returned signed to Selling Concept SRL by e-mail : <u>info@beoptic.be</u>, or by mail to Selling Concept SRL, BE OPTIC Registration, Droogveldstraat 33, 3404 Neerlanden. The exhibitor declares by the signed registration form his agreement and application of all clauses from the rules.

1.3. OBLIGATIONS AND RIGHTS - GENERALITY

- a. In the case an unexpected event happens as the non participation of one or several exhibitors, Selling Concept SRL will not refund the amount already paid by this cancelled exhibitor(s). In case of a reduced quantity of exhibitors, the participants are not authorized to cancel their registration or to claim a reduced participation fee. In case of cancellation, the expenses already made by Selling Concept SRL for the organisation of the fair will be claimed by the organizer to the cancelled exhibitor(s). The exhibitors cannot claim any compensation. In case of cancellation of the fair by Selling Concept SRL, the received amounts already paid by the exhibitors will be refunded.
- b. During the openings hours of the fair (starting at 7.00am) the exhibitors are the only responsible of their booth. There must be always at least one representative of the company on the booth .
- c. Animals are not admitted inside THE EGG neither in the outbuildings.
- d. Smoking is strictly forbidden in THE EGG or the outbuildings. It is the same rule during the set up of your booth at the beginning of the fair and the cleaning up of your booth at the end of it (Law from 19.01.2005).



- e. All costs and damages made by the exhibitor or which have been noticed on the booth after the fair are at full charges for the exhibitor and will be claimed by the organizer Selling Concept SRL as extra cost above the participation amounts already paid by the exhibitor at his registration.
- f. The stipulations of the present rules represents the whole engagement of the concerned parties. The fact that one or more clauses haven't been requested by one of the parties, doesn't mean that these rights are not applicable.
- g. The courts of Brussels are the only one competent in case of dispute. From their participation the exhibitors must remain responsible from their booth during the whole fair.
- **h.** In case of inadmissibility, all complaints from an exhibitor against the organizer of the fair, Selling Concept SRL, must send a mail against signature of the receiver, the organizer, at latest two weeks after the fair.
- i. Due to the risks linked to the Covid19 crisis, all exhibitors and their staff undertake to respect the sanitary measures which will be in force at the time of the show.

CHAPTER 2 – THE FEE DUE BY THE EXHIBITOR

2.1 FEE PER BOOTH

The fee is due for the period of the fair and covers the place of the booth and the services taken care of by Selling Concept SRL: tables, chairs, banners, invitation cards, drinks, catering, receptionist, parking, parking boy, security agent, insurance, website of the fair, etc... The price per exhibitor depends of the choice of the proposed. The prices are in Euros excluding the VAT (21%)

2.2 PAYMENT MODALITY

- a. The exhibitor will receive an invoice equivalent to 100% of the stand price upon receipt of the registration form. The invoice is payable upon 30 days. The registration is confirmed when the pro-forma invoice is paid. The exhibitor will only be accepted at the fair when the invoice is paid as stipulated in this contract within the requested time limit.
- b. Important information for foreign exhibitors concerning the VAT application. Since the 1st January 2011, only the access and the performance linked to the access where the event will take place will be subject to the VAT. All other performances will be subject to the new rule (perception by the taker). The VAT will no more be applicable to foreign exhibitors.
- C. If case of non payment on the requested date limits for even a small amount or due to bankruptcy or insolvency, the exhibitor will loose the reserved booth and without notice, the exhibitor will pay 10% of late fees every beginning month until the due amount has been paid.



d. Once the inscription form has been sent by the exhibitor, he's obliged to go on with his registration request and pay the total amount even if he wishes to cancel it for whatever reason.

CHAPTER 3 – EXHIBITORS AND SHOWED PRODUCTS

3.1. RESTRICTIONS & SANCTIONS

- **a.** Only the brands and materials mentioned on the registered form and which are conforming to the present regulations are allowed on the fair in the authorized limits of the booth.
- **b.** The booths must be occupied by the contract holder who will only expose the brands and products as requested on the registered form. The contract holder is not allowed to give, to rent or to exchange on free base or for payment to a third party unless approved by Selling Concept SRL.

CHAPITRE 4 - VARIOUS

4.1. PHOTOGRAPHY

Selling Concept SRL has the right to take pictures during the fair. These pictures will be used for informational and communicative purpose only for the website of the fair and the Facebook page linked to this event. Every exhibitor has the right to ask a digital copy of the pictures taken during the fair.

PUBLICITY

It is forbidden to show or to make publicity in favor for other brands or products not mentioned on the registered form from the exhibitor.

EXONERATION OF THE RESPONSABILITY

In case one of the exhibitors won't respect the actual regulations or other legal regulations, the exhibitor will take the complete responsibility of the violation and warrants Selling Concept SRL against all pursues from the situation and against all claims and damages.

4.2. JURIDICTION CLAUSE

All disputes concerning the application or interpretation of the present regulations will be forwarded exclusively to the courts of Brussels.

4.3. LEGAL ASSURANCE

The exhibitors will insure their goods and members of their personnel as conform from the legal dispositions.

4.4. THEFT

As previously mentioned a security guard will be available during the fair at THE EGG. This service is not a warranty against theft. If the exhibitors wishes an extra person in their booth, they can but at their charge. Also, Selling Concept SRL requests his exhibitors to take an insurance for all risks which also includes theft. These insurances allows a declaration of a theft to the Police in short notice.



Selling Concept SRL cannot be held as responsible in case of loss or theft of material and products.

4.5. RESPONSABILITIES

Neither Selling Concept SRL, neither THE EGG, neither the city of Anderlecht can be responsible in case of partial or total interruption of the lights, electricity or water which would cancel or interrupt the event. This is also applicable in case of fire, theft, loss, accidents or damages to objects or furniture in the buildings.

4.6. NON APPEAL

The contracted parties and their insurance contracted to this regulation confirms they will not go into any appeal against themselves or:

- THE EGG, whom provide the building and certain services to the fair
- Selling Concept SRL, organizer of the fair

- organs, personnel, agents, etc. This non appeal needs explicit to be mentioned in the contract between the exhibitor and the insurance.
